■ DISTRIBUTION ■

Products are distributed from logistics centres located with a view to optimize transport efficiency. The Reference Product is therefore transported over an average distance of 780 km by road transport from our warehouse to the local point of distribution into the market

■ END OF LIFE I

The product end-of-life factors are taken into account during the design phase. Dismantling and sorting of components or materials is made as easy as possible with a view to recycling or failing that, another form of reuse. This product falls within the scope of the WEEE directive (2012/19/EU). Therefore it must be processed through local WEEE recycling/recovery channels.

• Elements to process specifically:

• Extended producer responsability:

• Recyclability rate:
