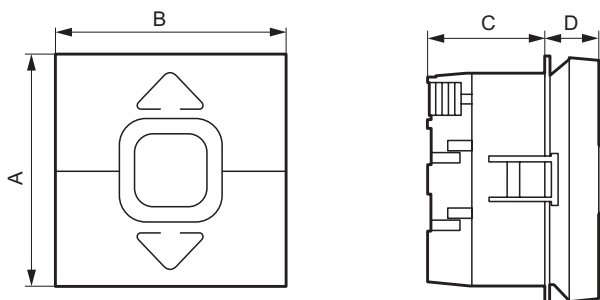

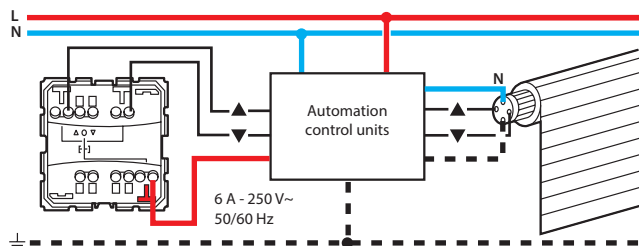

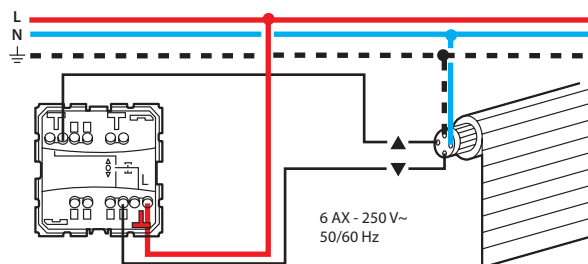

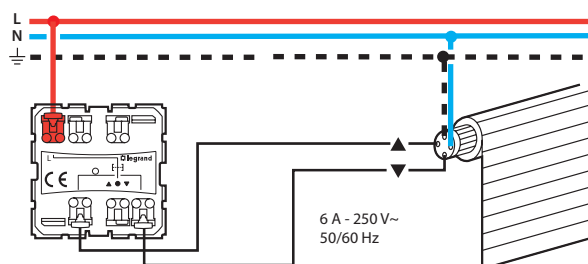
■ 4.1 Pushbutton wiring (Cat. No. 0 770 25 - 0 792 25)



■ 4.2 Switch wiring (Cat. No. 0 770 26 - 0 791 26 - 0 792 26)

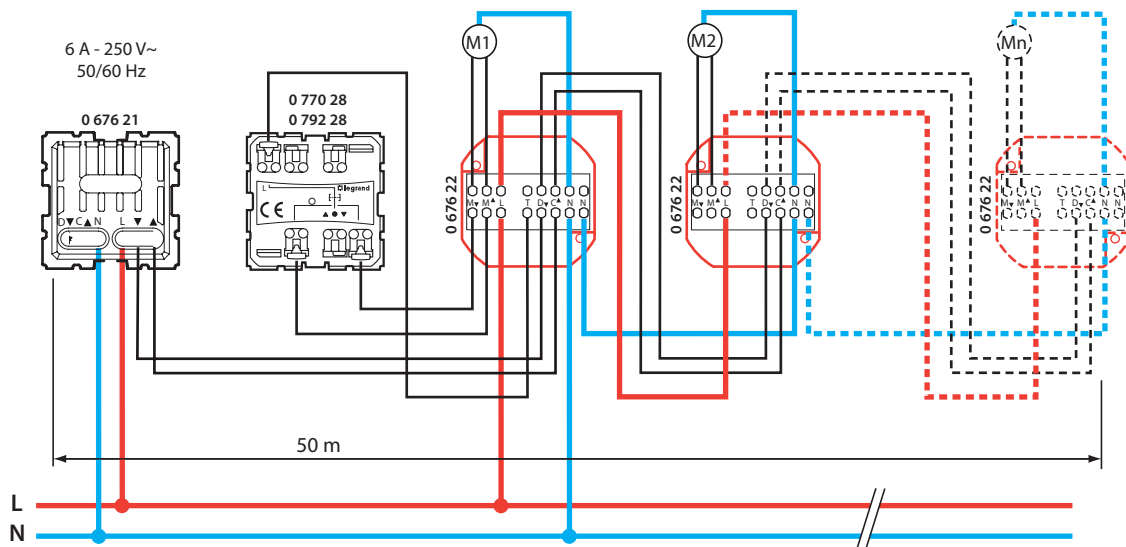


■ 4.3 Pushbutton wiring (Cat. No. 0 770 28 - 0 792 28)



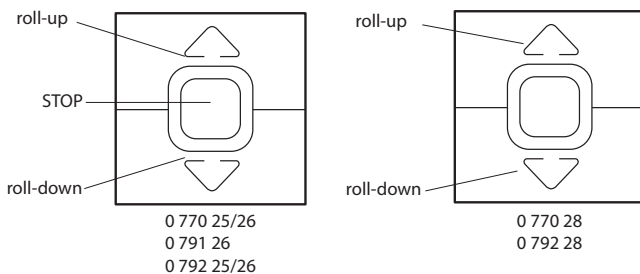

6. OPERATION

Cat. Nos. 0 770 25 - 0 792 25: double pushbutton for controlling one or more opening motors via automation control units (closing mechanism).
 Cat. Nos. 0 770 26 - 0 791 26 - 0 792 26: double switch for direct control of opening drives (fixed position mechanism).
 Cat. Nos. 0 770 28 - 0 792 28: double pushbutton for relay control (closing mechanism) of motor opening (without STOP).
