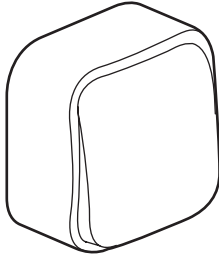

■ MANUFACTURE

This Reference Product comes from a site that has received ISO 14001 certification.



■ DISTRIBUTION

Products are distributed from logistics centres located with a view to optimize transport efficiency. The Reference Product is therefore transported over an average distance of 1405 km, by road from our warehouse to the local point of distribution into the market in Europe excluding France.

Packaging is compliant with european directive 2004/12/EC concerning packaging and packaging waste. At the packaging end of life, its recyclability rate is of 71% (in % of packaging weight).

END OF LIFE

Development teams integrate product end-of-life factors in the design phase. Dismantling and sorting of components or materials is made as easy as possible with a view to recycling or failing that, another form of reuse.

• **Recyclability rate:**

Calculated using the method described in technical report IEC/TR 62635, the recyclability rate of the product is estimated at 92 %. This value is based on data collected from a technological channel using industrial procedures. It does not pre-validate the effective use of this channel for end-of-life electrical and electronic products.

Separated into:

- plastic materials (excluding packaging) : 73 %
- metal materials (excluding packaging) : 7 %
- packaging (all types of materials) : 12 %



ENVIRONMENTAL IMPACTS

The evaluation of environmental impacts examines the stages of the Reference Product life cycle: manufacturing, distribution, installation, use and end-of-life. It is representative from products marketed and used in Europe excluding France.

Distribution	Transport between the last Group distribution centre and an average delivery to the sales area.
Installation	Installation components not delivered with the product are not taken into account.

End of life	In view of the data available on the date of creation of the document, and in accordance with the requirements of the PCR of the «PEP ecopassport» programme, transport of the Reference Product by road only once, over a distance of 1000 km, to a processing site at end of life was counted.
